I, Tiffany Equan Villalpando, Harris do hereby state,

I am the mother of Shamorea Villalpando, Koresheonna Villalpando, Steven Willingham, Kaireona Harris, Kintareia Harris, Kani Harris, Kapri Harris, and Keona Villalpando.

This Declaration is written " In support and on behalf of the lives of innocent children, mothers, fathers and families. "In support of babies that are dying, suffering, being killed, being raped, being institutionalized, being severely medicated with psychotropic drugs, and for the parents and families being "railroaded" and black balled", when trying to report such said violations. "In support of those that are being severely abused, neglected, mistreated, being molested, sent to jails, prison, and/or mental hospitals. "In support of Laws to be changed and decreed in the land and for me and my college becoming Advocates for the rights of Children, Mothers, Fathers and Families who have NO voice, "In support of due diligence for this type of abuse to be investigated and so that it can be reported and no longer ignored and treated like an everyday transaction and occurrence. "In support of reporting and investigating this type of abuse and neglect, so that we will not continue to be ignorant and ignore the detrimental and damaging effects that an illegal separation of a family can cause. "In support of alerting proper authority of the deadly and poisoned tactics and practices of DFPS-CPS and the Judicial System. "In support of "identifying and eliminating such violated practices. "In support of truly protecting children from abuse while realigning and erecting families safe plans, "In support of weakening the burden of these unjust systems the (DFPS-CPS and JUDICIAL SYSTEM) where children and families are being torn and broken apart and made out to become a menace to society with NO HELP of returning to their natural state of being neither as child nor as a stable human being in today's society, "In support of "an Inner and Out of State Quality Control Support Program that monitors, Children's and Families in foster-care programs; so that this doesn't continue to disassemble our United Nations, and finally "In support of Awareness Now to let the public know about the injustice done to me Tiffany Villalpando, Harris, Steven Willingham, Kaireona Harris, Kintareia Harris, Kapri Harris Kani Harris, Keona Villalpando and to children, mothers, fathers and families across Tarrant County Texas and across the Nations.

- 1. I am immensely in need of your assistance and services for me and my family and I would like to meet with you. My name is Tiffany Equan Villalpando; I am the mother of 8 children, 6 of whom were kidnapped by police and DFPS-CPS on 12-26-2009, in Tarrant County Texas.
- 2. Mr. President, if you do not meet with me I fear the (DFPS-CPS, the policemen, 33rd Court, Judges Jean Hudson Boyd, Judge Kimberly Brown, Attorney's and several different DFPS-CPS employees); will continue to injure, oppress, threaten and intimidate me, my children and any witnesses that stand with me. I implore your assistance so that these people cannot continue in their debauchery; in which if not addressed I sense the end result will be that; I will never see my 6 children again, or I will be killed, or put in jail.

- 3. President Trump, my children and I are suffering from mental pain, oppression, harassments, threats and various forms of intimidation by the power, authority and hands of the aforementioned individuals who have inflicted upon us this horrific trauma and livelihood for me, my 6 children's lives here in the state of Texas for almost 3 years now and also; any of the unheard voices of innocent children, mothers, fathers, and families across the nation.
- 4. Mr. President, while fighting for my rights and the release of my 6 children; I have endured inflictions such as threats, harassments, nearly arrested several times, detained by policemen, held a prisoner, held at gun point, nearly put in an institution, and nearly had my freedom taken from me in Probate Court all while in attendance in the 323<sup>rd</sup> Juvenile District Court, I was denied my parental rights, denied visits and phone calls for no given reason; and as of today, I am not given justice for Due Process of Law by; DFPS-CPS, the policemen, 33rd Court, Judges Jean Hudson Boyd, Judge Kimberly Brown, Attorney's and several different DFPS-CPS employees.
- 5. Mr. President, I am INNOCENT, and my children are INNOCENT and yet they are suffering from the atrocities and malice acts from the very persons, programs and systems that are supposed to protect all children from abuse or neglect of any form or kind. My children are being severely neglected and abused at this very moment; as they have been subjected to mental hospitals, placed in girls homes, foster homes, placed on psychotropic drugs (against my will and parent rights), my 6 children are not allowed to be placed with, nor see, nor communicate with me, family nor fictive-kin. My children are suffering from mental trauma inflicted upon them which is very significant to the fact that they were ripped away from a safe environment and from a loving and caring mother on December 26, 2009.
- 6. President Trump, as of the date of this letter I am being denied DUE PROCESS OF LAW in the 323rd Court.
- 7. On July 4th, 2009 1 relocated from Flint, Michigan to Texas with my 8 children, due to a very tragic family matter. Shortly after my 8 children and I arrived in Texas, which had only been 5 months on 12-26-2009 this tragedy began.
- 8. On the 26<sup>th</sup> of December 2009, I was held hostage at gun point, threatened, intimidated and treated with cruel unusual punishment for several hours (7 pm thru almost 3 am the next morning) in my home by the police and DFPS-CPS and my 6 children were kidnapped in the middle of that same night from my home. The 323rd Court didn't even have jurisdiction over my 6 children nor I; for we had not been in the state of Texas long enough to be considered Texas residents. Therefore, me and my 6 children were still residents of our home state Michigan under UCCJA.
- 9. Mr. President, no matter what happens to me; I will NEVER stop fighting for my 6 children in the state of Texas, God forbid that they continue to suffer as I continue to fight as well.
- 10. Mr. President the only thing left for them to do to me is to kill me or my 6 children, right now the case is in 6 different courts at this present moment as we speak. Here is the list of Courts for your records.

- 11. Mr. President, I have telephoned your office several times with a sense of urgency to set up a meeting with you as soon possible. Each time I tried, I was redirected to contact several different numbers to reach you and finally I have been directed to correspond with you by letter to set up a face to face meeting with you and or your colleges. To date I have not received any help from any of the agencies that I have contacted for over a period of two years and

four months now. Mr. President, however I am still in great need of your authority, your compassion, assistance, your voice, my voice, my children's voices and the voices of my colleges; to stand, fight, declare and decree laws to be changed to protect innocent children, mothers, fathers, and families across this nation. Please respond to this letter within 10 days from the date of letter lives are at stake.

- 12. Mr. President, I beseech you to save and protect innocent and powerless children, mothers, fathers, and families across the United States of America and currently my life and the lives of my 6 children are in jeopardy.
- 13. Mr. President, I have contacted several state and congress members including former president of the United States of America Mr. Barack Obama. I have also written letters to different people trying to invoke a voice for Freedom, Justice, Peace, Rights and for the Laws of the land to be changed in this corrupt and unjust system meaning the (DFPS-CPS and the COURTS) that conspire to dissect families with the judicial legal system here in the state of Texas and abroad. As a people, this is a tragedy to our nation to continue to allow DFPS-CPS, Courts, Judges, Attorney's, Police to destroy families claiming for the "Best Interest for Children" when the only best interest in it is; self-serving and self-gain for DFPS-CPS, Courts, Judges, Attorneys, and the Policemen enormous bank accounts with money running over at the expense of innocent children, mother, fathers and families suffering.
- 14. By means of governmental entities, judicial systems and or agencies receiving "Emergency Relief Funds" paid with Governmental money under Title IV services; this is creating a society of families that are damaged with mental anguish and fear. All the while innocent babies, children, helpless mothers, fathers and families suffer by the hands of those who initiate and inflict this trauma on our families such as (DFPS-CPS, Courts, Judges, Attorney's, and the Police) who are driving nice car's such as (Mercedes, BMWs, Yukon's, Range Rovers etc.) living in nice homes at the expense of innocent human beings suffering.
- 15. Mr. President you are in a position to shed some light on this serious issue in congress; for the Laws of the Land was put in place to protect the people NOT violate innocent people and deny them their Constitutional Rights and the right to DUE PROCESS OF LAW.
- 16. Mr. President again my name is Tiffany Equan Villalpando, and I would like to meet with you to discuss some laws that need be addressed and changed if the state of Texas and Michigan or any other state with a DFPS-CPS system in their states, truly want to protect innocent children from abuse and neglect of any kind or any form. The DFPSCPS system across the Nation need be changed to better STOP abuse & neglect of innocent children, mothers, fathers, and families. So that TRUE and HONEST JUSTICE will be served to the people and NOT denied.
- 17. Mr. President please know and believe if not for my faith in JESUS CHRIST himself, handling all my legal issues. I have no doubt that I would not have made it thus far considering all that is happening to me and my family.
- 18. Mr. President, I need your HELP to stand and fight with me my colleges to save lives, the lives of innocent children, babies are dying, suffering, being killed, being raped, being institutionalized, being severely medicated with psychotropic drugs, parents and families being "railroaded" and black balled", being severely abused, neglected, mistreated, being molested, being sent to jails and or prison, or mental hospitals. The burden of these unjust systems the (DFPS-CPS and JUDICIAL SYSTEM) causes the end result as such; that innocent children and families are being made out to become a menace to society with NO HELP to return to their natural state of being neither as a child nor stable human being in today's society.
- 19. Mr. President I would like to be an Advocate along with my colleagues for Children, Mothers, Fathers and Families who have NO voice, so that this type of abuse and neglect doesn't go unreported and so that we will not continue to ignore detrimental and damaging effects of this deadly and poisoned DFPS-CPS/Judicial System.
- 20. Mr. President I would like to meet with you as soon as I can to discuss the possible erection of "an Inner and Out of State Quality Control Support Program that monitors, Children's and Families in foster-care programs and reevaluate these LAWS in this DFPS-CPS system, state Laws and Constitutional Rights.
- 21. Mr. President if you will be so kind as to please meet with me, I will be grateful; for there is a need far beyond you and me. This is a need across the Nation, and I will NOT STOP until I directly reach the President, Congress, and

- the public. For the laws of the land need be change to truly and honestly protect Children and Families from the abuse and neglect of the legal system and governmental entities.
- 22. Mr. President, we as a people must stand together to protect the rights of people, especially whenever innocent human being's life source is in danger.
- 23. In the end JUSTICE will be served across this Nation and LAWS will be changed for the Better, for GOD (JESUS CHRIST) himself will execute his Judgment against all who are unjust, deceitful, evil and dishonest, murders, and all those who brings oppression on innocent people.
- 24. Our United States Constitution was drafted upon the principles of the Bible, "United We Stand, and Divide We Fall" this was indoctrinated by our Fore Fathers as this was echoed and etched in the hearts of "We the People" of this society. They believed that this would be carried out; in so much that it was decreed that our Nation's tender be sealed with "In God We Trust". Likewise our "Pledge of Allegiance" in which states "One Nation Under God", which means "Equal Rights and Justice" for all.
- 25. Knowing this TRUTH about our Fore Father's faith in God and our faith as a Nation as a people we should also know that the Bible also states warnings to all who hurt and/or oppress innocent people.

\*\*\*The United States Court of Appeals for the Ninth Circuit said it best, "The government's interest in the welfare of children embracers not only protecting children from physical abuse, but also protecting children's interest in the privacy and dignity of their homes and in the lawfully exercised authority of their parents" <a href="Calabretta v. Floyd. 189 F. 3d 808"><u>Calabretta v. Floyd. 189 F. 3d 808</u></a> (9th Cir. 1999).

PERMANENT TERMINATION OF PARENTAL RIGHTS has been described as the family law equivalent of the Death Penalty in a criminal case- Therefore, parents "must be afforded every procedural and substantive protection the law allows". Smith (1991), 77 Ohio App.3d. 16.601 N.E.2d 45.54.

Mr. President, I will be waiting for a favorable response and meeting with you ASAP. Please respond to my letter in writing within 10 days from the date of this letter for LIVES are at stake.

Thank you so much for your time and attention to this matter. Your services to me are deeply warranted, seriously needed and will be greatly appreciated.

Mr. Trump we humbly anticipate your pressing response in this matter to stand, fight and to be a voice with me and my colleges.

#### Dear TIFFANY.

Thank you for taking the time to reach out to me and share your family's experience with the Child Protective Services (CPS) program, in the Michigan Department of Health and Human Services' (MDHHS). I am grateful for your correspondence and the opportunity to respond.

Our Children's Protective Services program is responsible for investigating allegations of child abuse and neglect. If you suspect abuse or neglect, please immediately call (855) 444-3911. If you feel that you have a concern that is not being addressed regarding the handling of a case involving the safety and welfare of a child, there are avenues to submit your complaints and feedback.

For complaints against CPS itself or a CPS caseworker, please call the Office of Family Advocate at (517) 241-9894. If you feel a case was not handled properly because of a violation of statute, administrative rule or policy, I urge you to call the Office of Children's Ombudsman (OCO) at (800) 642-4326. The OCO is an independent state agency that investigates complaints about children involved with protective services, adoption services, and juvenile justice facilities and assesses if MDHHS and adoption agencies followed laws, rules and policies.

Every child deserves to be raised in a safe and healthy environment, and my office is committed to ensuring everyone has the resources they need to alert the state of any instances of suspected abuse or neglect. I encourage you to report any cases of suspected abuse and neglect to MDHHS - Centralized Intake at (855) 444-3911. The Michigan Child Protection Law, Public Act 238 of 1975, places strict guidelines on what information can be shared about these investigations, and so you may not be included in the investigation or kept updated with any developments in the investigation.

I, or members of my staff, do not have the ability to provide constituents with legal representation or counsel. For additional information about legal resources and tools for support available in your community, please visit www.michiganlegalhelp.org. If you need help finding an attorney, you may contact the State Bar of Michigan's Lawyer Referral Service at (800) 968-0738. For a \$25 administrative fee, a referral assistant will match you with a participating attorney who will provide up to a 25-minute initial consultation free of charge. This service is available Monday through Friday between 8:45 a.m. and 4:45 p.m.

Allegations of child abuse and neglect are serious and must be handled with the best interest of the child as a priority. I hope this information is helpful. Thank you again for reaching out to my office and please do not hesitate to contact me again about any issue of importance to you.
