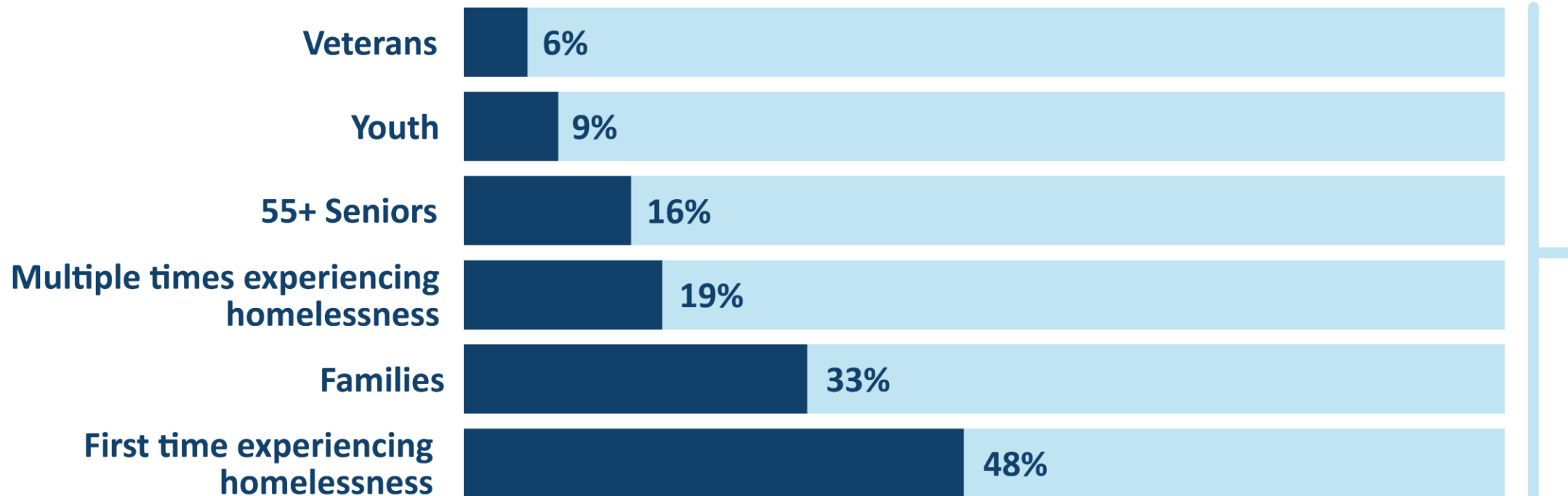

Homelessness in Michigan

2024 Unhoused Population

Michigan: **6% decrease** from 2023

National: **18% increase** from 2023

MDHHS's Role in Ending Homelessness

MDHHS grants more than

\$60 million

in state and federal funds
(71% federal and 29% general
fund) to more than 84
nonprofit direct service
agencies across Michigan.

MDHHS's Role in Ending Homelessness, Continued

This funding supports a variety of services:

1 million

Providing more than one million nights of emergency shelter and moteling for unhoused adults, families and youth.

2,700

Providing rental assistance for more than 2,700 people who previously experienced homelessness.

1,000

Providing supportive services for more than 1,000 people in permanent supportive housing so they can remain housed.

800

Enrolling 800 unsheltered individuals with mental health, substance use disorder and physical disabilities in programs and services to get them housed and safe.

1,456

Connecting with an additional 1,456 unsheltered individuals to offer services and shelter.

Long-Term Programs

- Emergency Shelter Program (ESP).
- PATH (i.e., street outreach).
- HUD Rapid Rehousing (RRH).
- HUD Permanent Supportive Housing (PSH).
- Homeless Youth and Runaway Program (HYR).
- HUD Housing Opportunities for Persons with AIDS (HOPWA).
- SOAR (SSI/SSDI Outreach, Access and Recovery) .



New Investments

- Emergency Housing Fund (EHF) for Child Welfare Involved Families: \$3.5 million Temporary Assistance to Needy Families (TANF).
- PSH Supportive Services Pilot and Transformation Fund: \$20 million (\$10 million American Recovery Plan Act (ARPA) and \$10 million general fund).
- Master Leasing Pilot to Expand Family Shelter: \$7 million TANF.



Challenges



- Provider capacity issues
 - Staff turnover
 - Low wages
 - Insufficient housing case management
- Increased costs for shelter and rent
- Lack of affordable housing
 - Longer shelter stays
 - Limits number of people served
