MICHIGAN VOLUNTEER DEFENSE FORCE

Michigan law provides that the state military establishment "...consists of the Army National Guard, Air National Guard, and the Defense Force." (MCL 32.509). The Michigan Volunteer Defense Force (MIVDF) is established pursuant to the Michigan Military Act (MCL 32.509 et. seq.) as authorized by 32 USC § 109. The Governor of the State of Michigan is the Commander in Chief of the Defense Force, and the MIVDF operates under the direction of the Adjutant General of the State of Michigan.







The State Defense Force is a professionally-trained branch of the Michigan Military establishment, along with the Michigan Army National Guard and Air National Guard.

Mission

To provide ready and able military forces to assist state and local authorities in times of state emergencies, and to augment the Michigan Army National Guard and Michigan Air National Guard as required.

Ready and Able

With new leadership and renewed vision grounded in Michigan law, the new MIVDF is launching it's Ready and Able Program (R&A) designed to reengineer the force into a ready and able asset to the State of Michigan and the Michigan National Guard.



Sustained personal readiness to meet operational requirements through adequate training, funding and equipping.



Culture of values-driven excellence producing highly capable, trusted, defense force professionals.



Management that empowers all defense force personnel to energetically engage in the enduring mission of providing credible and versatile military forces.

Ready and Able Objectives

Support of domestic emergencies and humanitarian efforts in conjunction with civil authorities.

Support of regional homeland security operations IAW the EMAC and/or with FEMA and DHS partnership.

Support DMVA and MING with trained, competent and motivated personnel to assist with staffing, manpower and coordination of strategic tasks.

Support the state of Michigan with unwavering and steadfast resolve in defense of its borders in time of public danger, crisis or catastrophe.


Michigan Defense Force Education and Prior Military Service Demographics


Highest Level of Education


Served in the US Armed Forces


Prior Service Branch

Prior Service in the Michigan National Guard










State Defense Forces in the United States

In the United States, state defense forces are military units that operate under the sole authority of a state government. Twenty three states currently have an active State Defense Force. In similar fashion to the national guard, these troops drill monthly and annually. California, Georgia and Texas are among the states with the most active units, some of which are fully integrated with local national guard units.
