MINUTES

HOUSE APPROPRIATIONS SUBCOMMITTEE ON Transportation DATE: April 13, 2022

Chair VanSingel called the meeting to order at 12:00 PM. Representatives VanSingel, Borton, Brann, Lightner, Steckloff, and Sabo were present. Rep. Allor was excused from the meeting.

Rep. **Borton** moved to adopt the minutes of the March 23, 2022 subcommittee meeting. The motion was approved by voice vote without objection.

Rep. **Lightner** moved to adopt substitute H-1 for House Bill 5791. Representatives VanSingel, Borton, Brann, Lightner, Steckloff, and Sabo voted yes; the motion carried.

The House Fiscal Agency provided an analysis the bill. Copies of the HFA analysis documents are retained in the official file and are posted to the HFA website.

Rep. **Steckloff** moved to adopt amendment #1, to earmark \$1.5 million for improvements related to the M-1 rail line in Detroit. Representatives Steckloff, and Sabo voted yes; Representatives VanSingel, Borton, Brann, Lightner voted no; the amendment was **not adopted**.

Rep. **Steckloff** moved to adopt amendment #2, to direct the department to conduct a study of VMT as a basis for transportation funding. Representatives VanSingel, Borton, Brann, Lightner, Steckloff, and Sabo voted yes; the amendment **was adopted**.

Without objection, Rep. Steckloff withdrew an amendment labeled amendment #3,

Rep. **Steckloff** moved to adopt amendment #4, regarding Amtrak policing on Michigan train service. Representatives Steckloff, Brann, and Sabo voted yes; Representatives VanSingel, Borton, and Lightner voted no, the amendment was **not adopted**.

Rep. **Sabo** moved to adopt amendment #5, regarding a rail passenger feasibility study (New Buffalo – Traverse City). Representatives VanSingel, Borton, Brann, Lightner, Steckloff, and Sabo voted yes; the amendment was adopted.

Without objection, Rep. Steckloff withdrew an amendment labeled amendment #6,

Rep. **Borton** moved to adopt amendment #7, earmarking funding for the procurement of industrial magnetic sweepers. Representatives VanSingel, Borton, Brann, Lightner, Steckloff, and Sabo voted yes; the amendment was adopted.

Rep. **VanSingel** moved to adopt amendment #8, earmarking \$5.0 million to help implement low impact development stormwater management practices. Representatives VanSingel, Borton, Brann, Lightner, Steckloff, and Sabo voted yes; the amendment was adopted.

Rep. Borton moved to report House Bill 5791 (H-1), as amended, to the full House Committee on Appropriations. Representatives VanSingel, Borton, Brann, Lightner, Steckloff, and Sabo and voted yes; the motion carried. Chair VanSingel adjourned the meeting, without objection, the time being 1:00 p.m.
