Re: Support of HB 5726-5729: Anti- Pyramid Promotional Scheme Act

Dear Commerce and Trade Committee Members:

Team National, a Direct Selling company based in Davie, FL, would like to express support for HB 5726-5729 regarding Pyramid Promotional Schemes. The bill would clearly define and establish criminal penalties for operating or participating in a pyramid promotional scheme.

In 2016, over 381,000 Michiganders were involved in direct selling and the industry contributed over \$702 million in sales to the state. Over 20 million Americans are involved in direct selling in every state, Congressional district and community in the United States.

This bill does two simple things—clearly defines a pyramid scheme as any plan or operation in which compensation is provided primarily for the recruitment of others and makes such participation in a pyramid scheme illegal under state law. This legislation is needed to protect consumers because pyramid schemes are illegal businesses that masquerade as legitimate direct selling companies to defraud consumers. It would give law enforcement in Michigan more guidance on identifying and prosecuting pyramid schemes and guides legitimate direct selling companies on what constitutes acceptable business practices.

The bill would clearly differentiate the legal income earning opportunities offered by legitimate direct selling companies from the scams perpetrated by fly-by-night promoters of pyramid schemes. It also encourages adoption of a right of return for inventory purchased by individual direct sellers to ensure additional levels of consumer protection for direct sellers.

This language is largely derived from model legislation endorsed by the bipartisan Council of State Governments (CSG) in 2004. Specific legislation based on the CSG model or highly similar to it has been subsequently enacted into law in 21 states including Idaho, Washington, Georgia, Utah, Nebraska, Virginia, and Tennessee as those states moved to update their laws. In 2017, similar language passed through the Indiana, New Jersey, and South Carolina legislatures unanimously and were signed into law. The legislation protects consumers by providing guidance on identifying illegal businesses and provides clarity for legitimate direct selling companies on ethical business practices.

Nobody wins when pyramids schemes prevail. Not consumers or legitimate direct selling companies. **Team National urges** you to support HB 5726-5729 protect consumers and provide guidance to legitimate direct selling companies and Michigan's independent direct sellers. Thank you.

Dear Commerce and Trade Committee Members:

I am writing on behalf of Shaklee Corporation ("Shaklee") to voice its strong support for HB 5726-5729 respecting pyramid promotional schemes. The bill would clearly define and establish criminal penalties for operating or participating in a pyramid promotional scheme.

Shaklee is a direct selling company founded in 1956 which sells all of its products via independent contractor distributors. Thousands of such distributors reside in the State of Michigan. Nearly ninety percent (90%) of such distributors are women working from home to supplement the family income. They rely upon the flexibility that direct selling affords in allowing them to choose when to work, how many hours to devote to their business, and all the decisions that accompany owning their own businesses. They operate their businesses with integrity and do not wish to be confused with operators of illegal pyramid schemes.

This bill accomplishes two important objectives: it clearly defines a pyramid scheme as any plan or operation in which compensation is provided primarily for the recruitment of others and makes participation in such a pyramid scheme illegal under state law. This legislation would protect consumers from pyramid schemes that masquerade as direct selling companies; provide law enforcement with more guidance on identifying and prosecuting pyramid schemes; and guide legitimate direct selling companies concerning acceptable business practices.

HB 5726-5729 is based upon the Council of State Governments model antipyramid law (2004 Suggested State Legislation, Vol 63). This model or similar Michigan House of Representatives Commerce and Trade Committee Page 2

ones have been adopted in 21 states, most recently in Indiana, New Jersey, and South Carolina, where the bills passed the legislatures unanimously.

For all the above reasons, Shaklee urges you to support HB 5726-5729.
