FILING FEES: BILL PACKAGE SUMMARY

Public Act(s): PA 116 of 1954, PA 164 of 1877, and PA 261 of 1966

Statute(s): MCL 168.163, 168.193, 168.224, 168.254, 168.349, 168.351, 46.411, 46.411a, and 397.211

Bill Type(s): Single-Section (9 bills)

Tie-Bar(s): HB 4745-4750, HB 4809-4810, and HB 4823 (Companion)

(#1) HB 4745 Sponsor: Rep. Marino [Tie-barred to HB 4746-4750]

Amends MCL 168.163 by increasing the \$100.00 "filing fee in lieu of a nominating petition" for candidates seeking the office of state representative or state senator to \$400.00 and establishes that filing fees are nonrefundable and, if filed at the county-level, shall remain in a county's general fund.

(#2) HB 4750 Sponsor: Rep. Lilly [Tie-barred to HB 4745-4749]

Amends MCL 168.193 by increasing the \$100.00 "filing fee in lieu of a nominating petition" for candidates seeking the county offices of clerk, register of deeds, treasurer, prosecuting attorney, sheriff, surveyor, or coroner to \$200.00 and establishes that filing fees are nonrefundable and shall remain in a county's general fund.

(#3) HB 4746 Sponsor: Rep. Marino [Tie-barred to HB 4745 and HB 4747-4750]

Amends MCL 168.224 by increasing the \$100.00 "filing fee in lieu of a nominating petition" for candidates seeking the office of county auditor to \$200.00 and establishes that filing fees are nonrefundable and shall remain in a county's general fund.

(#4) HB 4749 Sponsor: Rep. Brann [Tie-barred to HB 4745-4748 and HB 4750]

Amends MCL 168.254 by increasing the \$100.00 "filing fee in lieu of a nominating petition" for candidates seeking the office of county road commissioner to \$200.00 and establishes that filing fees are nonrefundable and shall remain in a county's general fund.

(#5) HB 4747 Sponsor: Rep. Calley [Tie-barred to HB 4745-4746 and HB 4748-4750]

Amends MCL 168.349 by establishing a \$150.00 “filing fee in lieu of a nominating petition” for candidates seeking the township offices of supervisor, treasurer, clerk, and trustee.

(#6) HB 4748 Sponsor: Rep. LaSata [Tie-barred to HB 4745-4747 and HB 4749-4750]

Creates Section 351 to conform filing requirements for the newly created fee with other elected offices of the state and states that the filing fees are nonrefundable and shall be deposited in a township’s general fund.

(#7) HB 4809 Sponsor: Rep. Marino [Tie-barred to HB 4745-4750, HB 4810, and HB 4823]

Amends MCL 46.411 by increasing the \$100.00 “filing fee in lieu of a nominating petition” for candidates seeking the office of county commissioner to \$200.00 and establishes that filing fees are nonrefundable and shall remain in a county’s general fund.

(# 8) HB 4810 Sponsor: Rep. Kosowski [Tie-barred to HB 4745-4750, HB 4809, and HB 4823]

Amends MCL 46.411a to establish that the “filing fee in lieu of a nominating petition” for candidates seeking the office of county commissioner shall be nonrefundable and shall remain in a county’s general fund.

(#9) HB 4823 Sponsor: Rep. Webber [Tie-barred to HB 4745-4750 and HB 4809-4810]

[Companion Bill to HB 4747-4748] Amends MCL 397.211 by aligning the existing \$100.00 filing fee for candidates seeking the office of township library board with the \$150.00 fee proposed in HB 4747-4748 while also establishing that filing fees are nonrefundable and shall remain in a township’s general fund.
